INVITATION TO BID

Supply & Delivery of Spare Parts (KIA 2700 SHE 660)

- 1. The Local Government Unit of Kapalong, through the **General Fund 2019** to apply the sum of **Four Hundred Eighty Seven Thousand Seven Hundred Fifty Pesos Only (487,750.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply & delivery of Spare Parts**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Kapalong now invites bids for **Supply & delivery of Spare Parts.** Delivery of the Goods is required **of 10 Calendar Days**. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from Local Government Unit of Kapalong and inspect the Bidding Documents at the address given below during office hour **8:00 AM** to **5:00 PM**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 15**, **2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **(P500.00)**.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. Bids must be duly received by the BAC Secretariat at the address below on or before **April 29**, **2019** at **1:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
 - Bid opening shall be on **April 29, 2019 at 1:00 PM.at CDIC Building Municipal Compound, Maniki, Kapalong, Davao del Norte**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. Interested Bidders shall submit Letter of Intent (LOI) and notarized authorization as representative from the proprietor/company to attend the Pre- Bid Conference and Bid Opening.
- 8. The Local Government Unit of Kapalong reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
